TOURNAMENT CONDITIONS

Dear fellow shooters,

Throughout 2025 on a military range Kovačevo (Grobnik) near Rijeka (Croatia), in four rounds*, KDS „Omega“ - Rijeka organise in both FTR and FO, 600 m F-Class individual hobistic competition.

Planned** dates are:

*Planned number of rounds is four. Organizer reserve the right to postpone or cancel certain round in case it appear not to be economical due to short number of competitors. In such case it will be dealt with paid entries in same way as with postponement or cancelation due to force majeure.

**Organizer reserve the right to change planned dates that could be caused by force majeure (e.g. bad weather) or unforeseen priorities of range usage by the owners (Ministry of Defence).

Each round will be organised during weekends, on Saturdays FTR (3 matches, 2+15, 2+15 and 2+20, each in two details) and Sundays FO (3 matches, 2+15, 2+15 and 2+20, each in two details). It is max 48 shooters per discipline. Each day will commence at 08:00 by weighing and marking rifles.

Except for weighing and shooting, rifles must be in safe condition with bolts removed and ECI – breach flag inserted into the chamber. *Use of camouflage clothing is not allowed.*

Competition will be in pair shooting according to the ICFRA FC_Rules_2023-Rev-2 (Bisley style-alternate pair shooting). Shooting commences by right shooter of the pair followed by left one continuously alternating until all match shots are fired. Right one takes records for left one and vice versa. Two convertible shots precedes fifteen match shots in 1st and 2nd match and twenty shots in third match.

Each competitor have a choice to convert either both or second sighter only.

At 09:00 commences rifles shooting-in. We shall use gong for shooting-in and until each and every competitor succeed to achieve an impact. At your disposal will be two gongs (size 50x50 or 50x40 cm). One gong will be positioned on the left side of target #1 and other one on the right side of target #12. Shooters on targets 1 to 6 will use left gong and shooters on targets 7 to 12 will use right one.

As squaded for first match and shooting-in, shooters will continue with 10 min practice (alternating). After short 10 min practice that will be available before 1st match only, shooters will at Range Officer's (RO's) notice start their 1st match 2+15. Time frame for the 1st match is 35 min.

Upon 1st detail complete their 1st match, there will be a 10 min change of detail.

In same manner the 2nd detail will execute shooting-in, short practice and their 1st match.

Upon completion of 2nd detail's 1st match, 1st detail will take place on the firing line and commence 2nd 2+15 match. Following 1st detail, the 2nd one will execute their 2nd match.

Shooting will then continue with 3rd match, 2+20 shots. First follow by second detail. Time allowance for 3rd match is 45 min.

Each day will be completed by awarding ceremony for the Round.

 Electronic targets Shotmarker will be used for the tournament, distance 600 m in accordance with Annex F/B of the Rules. For target monitoring purposes please provide your own smart phone or tablet. Assure your batteries are charged. We recommend to have spare power supply such as battery banks. In case of trouble connecting to the target network please contact any of the ROs who will assist or provide our own display.

Apart of electronic record keeping, competitors will maintain manual score cards provided by organizers. Record keeper have to say, loud and clear, each shot value to the shooter, who in exchange have to confirm said value. Once the shot value is agreed it will be recorded in the score card and shooting may continue.

At completion of shooting, shooters in each pair have to remove bolts and visually check that each other's rifle chamber is empty-have a look through the barrel (barrel pointed towards targets) and insert the ECI-Breech flag into it. As soon as rifles are checked and safe, competitors have to clear the firing line. Once their gear is clear away, competitors can complete their score cards, sign as appropriate and pass them to ROs. Score Cards will be used only as comparison to electronic records which in case of disagreement prevails. It is very important that during the match competitors report occurrence of any anomaly (unregistered shot by the system „ghost shot“, crossfire shot, out of turn shot, etc.) so the ROs could properly correct the electronic records. In accordance with the Rules for each „ghost shot“ competitor will be allowed to repeat such shot, shooting the wrong target – „crossfire“ and out of turn shots will be penalised as per Rules.

Sum of all 3 match scores will give final score (aggregate) of the round. Ties in the aggregate scores will be resolved by scores countback, starting with 3rd, then 2nd and lastly the 1st match of the day. If still tie and time permit, for first three places tie will be resolved by shoot-off (2NC sighters and 5 shots to count) followed by sudden-death until resolved or one of the shooters give-up. If time does not permit shoot-off and for 4th place down it will be resolved by flipping the coin. Medals will be awarded to first three competitors of each round.

Considering that tournament is actually in the league format, aggregates of each four rounds will be converted to points. Sum of points awarded in each round will give the final winners of the season 2025, but only if sufficient number of rounds will be executed.

The main sponsor of the tournament is Kahles – Austria. Prize fund will be announced during the tournament.

For each round with 30+ participants (per discipline) LRSC Omega shall reward medalists with their entry fee refund.

Award points (AP) for each round and discipline will be calculated as per following equation:

(AP) Award points = (A) Basic points x (B) Round ranking factor + (C) Number of competitors factor + (D) V bull factor

(A) Basic points

Round ranking factor (B) is calculated as follows: $B = 1 + \text{Number of ranked shooters who participated in the round}/100$. Basic points (A) are then multiplied by foresaid Round ranking factor (B). For example: In the Round where all 20 ranked shooters participated, competitor who took first place will be awarded 50 basic points multiplied by 1.2, i.e. 60 points – $50 \times (1+(20/100)) = 60$

For the Season 2025 the organisers, at their discretion, nominated following twenty ranked shooters:

For the next season 2026 ranked shooters will be named based on the results of season 2025 and for each discipline separately.

In case that any of the 2025 season ranked shooters does not agree with their nomination, kindly please contact organisers lrscomega@gmail.com upon receipt of this Tournament Conditions and we'll assure their replacement.

Number of competitors factor (C) is calculated as follows: $C = \text{Competitors participated in the round}/10$. Results will be added to previously multiplied $A \times B$. For example, if 48 competitors participated in the round, then $C = 48/10 = 4.8$ and this will be added to $A \times B$, i.e. following previous example, $50 \times 1.2 = 60 + 4.8 = 64.8$ points.

V bull factor (D) is calculated: $D = \text{Number of achieved V bulls}/50$ (max. No. of V bulls in the round). Result will be added to $A \times B + C$, for example if the winner of the round achieved 33 out of 50 V bulls, then $D = 33 / 50 = 0.66$, i.e. following previous examples, $AP = A \times B + C + D = 50 \times 1.2 + 4.8 + 0.66 = 65.46$ points

On completion of the 4th Round, sum of the award points achieved in three best of four Rounds or two best of three (in case of certain Round cancelation) will form List of the final results and winners of the Season 2025. In case of cancelation of two or three Rounds, winners will be announced for individual Round only, but not for the Tournament (Season) 2025.

Pre-registrations, by e-mail to the organiser's foresaid address, may commence on the announcement date of this Tournament Conditions <https://kds-omega.hr>. In your pre-registration please note the dates and disciplines you want to participate in for the entire Season. Furtherly, you will confirm your pre-registration by bank payment of the Competition entry fee to the organisers Bank Account (details on the bottom). Payment should be done for each Round separately and at least two weeks prior to each Round. After the said date un-confirmed pre-registrations will be voided assuming you could not participate in the Round. In case you confirm pre-registration by payment and for any reason did not participated you loose the right for refund. In case that organisers are due to objective reasons (force majeure) forced to postpone competition (round), same will be postponed to an alternative date (as per plan above) and all participating competitors will be timely informed. In this case, if competitor is unable to participate on alternative date he can request fee refund to his bank account. In case that organisers will be forced to cancel even on the alternative date, organisers will refund to all competitors who have paid their fees.

Entry fee is 70 EUR for one discipline/one day (3 matches).

Individuals who already paid 90 EUR entries for the 1st Round may request refund of the overpaid amount or may leave it as a credit for the entry to one of the next rounds (at their discretion).

Organisers will provide drinking water.

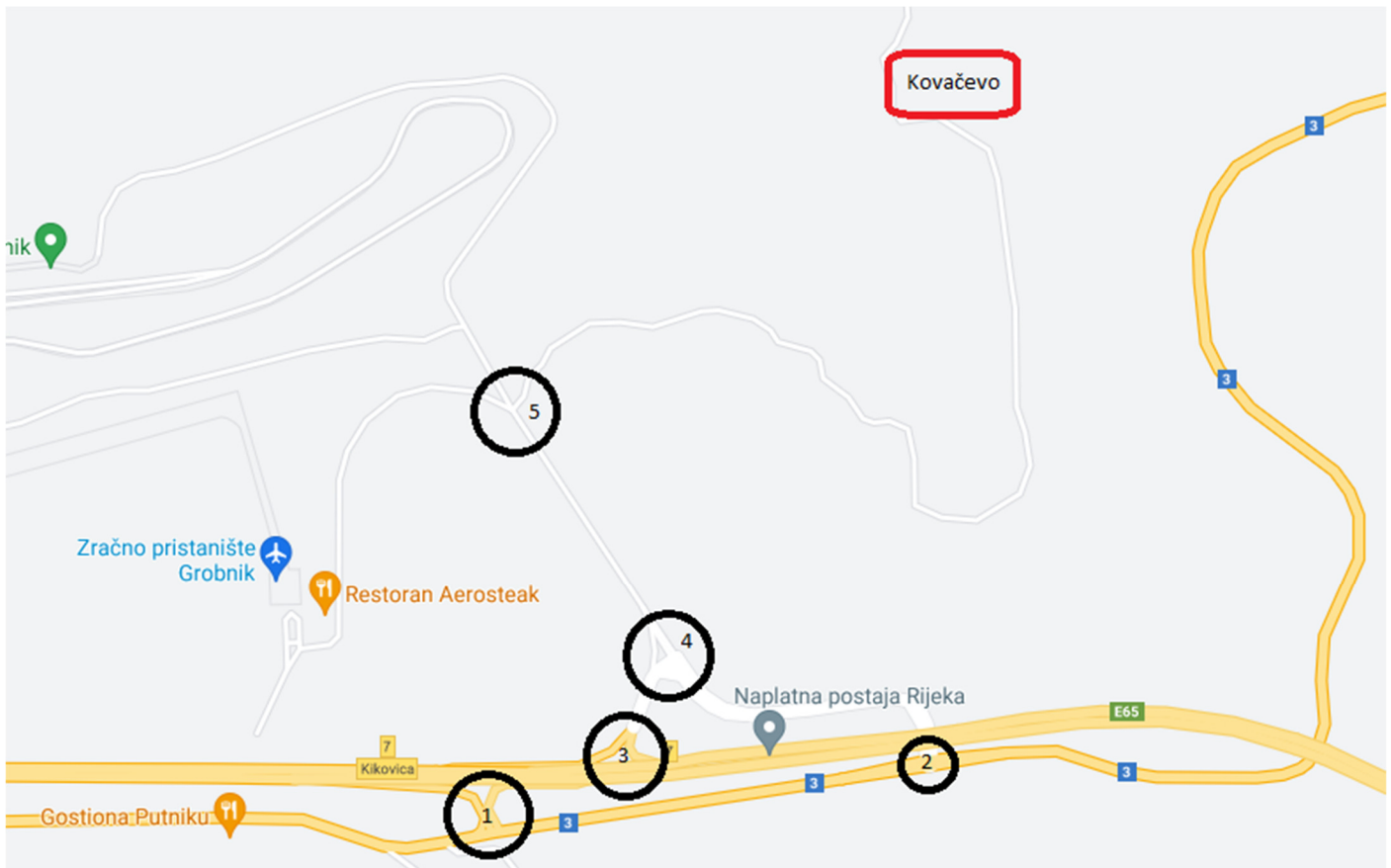
Shooting range have decent Toilet which kindly leave clean after use.

To all competitors who in time pay the fee, organisers will send Invitation Letter which (where required) is used to enter Republic of Croatia. Apart of Invitation Letter, competitors from abroad, entering Republic of Croatia must be in possession of valid national firearm licence and EU firearm pass (for EU citizens) and must declare their firearm/s and ammunition (number of rounds and caliber). Border Police and or Customs could require to see the arms and documentation.

Apart of Invitation Letter all participants will receive Disclaimer Statement which kindly complete, sign and return to Organisers *scanned copy by e-mail or* upon arrival at the range, but not later then at rifle weighing.

Shooting Range is situated at 340 m above sea level. Position is LAT 45.385612 N and LONG 14.525639 E or (45° 23' 08" N and 14° 31' 32" E).

Shooting Range Kovačevo is nearby Grobnik airfield and motodrome.



- If you are driving from the west (from Rijeka) you leave the highway on the exit 1, then turn left towards underpass 2. Proceed under the highway E65 and drive through crossroad 4 towards junction 5 where turn right and use „white road“ that will take you to the range Kovačevo.
- If you are driving from same direction (from west) but using the old local road 3 you'll pass the Gasthouse Putniku, then will pass by junction 1 continuing on 3 till underpass 2 where same as above.
- If you are driving from the east (from Zagreb direction) using highway E65, after the tollpay (Naplatna postaja Rijeka) take the right exit at 3, turn towards 4 and 5 and as above straight to the range.
- If you are driving from same direction (from east - Zagreb) but using old road 3 take the underpass 2 and as above.
